Check-up & handling of dangerous goods

1st check (ELI,ELM,ICE,RDS,REQ,RRE only) surcharge 800 CZK to Terminal fee/consignment

1st check (all other DGR types) surcharge 1200 CZK to Terminal fee/consignment

Check-up & handling of dangerous goods

2nd and subsequent checks (all DGR types) surcharge 2000 CZK to Terminal fee/consignment

Surcharge for the processing of express shipments as per point I.a (Handling of export shipments) is not charged in cases when the gross weight of the shipment is 100 kgs and less.



A.2 Storage of export consignments

Charges for storage:

Within 24 hours: free of charge

More than 24 hours of storage 6 CZK/kg/day

Split shipments

If customer requires shipments to be split into parts and handled separately, a Terminal fee will be charged according to the weight of the relevant part of the shipment. Release of a shipment separated into parts will be permitted in cases where the number of received pieces does not exceed the number of pieces on the MAWB. In these cases the shipment will be released only in whole to the recipient or his authorised representative, according to MAWB.



B.2 Storage of import consignments

All calendar days, including Saturdays and Sundays but not Public Holidays, are considered storage days.

Charge for storage is not applied for the service shipments of the partner air carriers.

Storage date: date and time when the complete shipment was received (all pieces as per AWB). If the storage date falls on Monday – Thursday after 3 p.m., or on Friday - Sunday, then the next working day is considered the storage date.

Charges for storage:

from the 1st to 4th day of storage free of charge

5th day or more of storage 6 CZK/1 kg/day

Delivery after business hours of the Import Landside reception: 100 % surcharge to the Terminal fee

Business hours of the cash desk: Monday – Sunday 7:00 am – 6:00 pm except for national holidays

In cases of AVI, HUM, LHO, PER, fresh flowers and express shipments, there will be no surcharge for delivery after business hours, only a surcharge for special products.

C. OTHER SERVICES

C.1 Shipment's security control 0,60 CZK/1 kg

C.2 Transport of goods between airport warehouses 800 CZK/consignment

C.3 Requested Manipulation

By forklift including operator:

VZV 1,5 t 2500 CZK/each started hour

VZV 2,5 t - 3,5 t 3500 CZK/each started hour

VZV 12 t 11000 CZK/each started hour

Note: The maximum operational weight of each piece is always dependent of its dimensions and required method of manipulation.
